I have felt it best to write this communication over the weekend and hopefully save the investigator from having to take the time to call me and document notes over the phone.

I consider this letter to be an extremely urgent matter [REDACTED] relating to [REDACTED] Brynia Kayle Harris-Czubko, born [REDACTED] considered to be deceased as of August 4, 2020 when her [REDACTED] body (in an advanced state of decomposition per the autopsy report – attached to this letter) was pulled from the Kern River along 178. This matter is urgent [REDACTED] Bakersfield Police Department [REDACTED]

[REDACTED] The dash cam videos are dated 8/03/2020.

I am Karen [REDACTED] originally from Tehachapi. [REDACTED] Brynia was my niece. I have every reason to believe the limp body in the 8/03/2020 was Brynia's deceased body, especially since the nearby car in the video was hers. I have attached a printout picture that includes GPS coordinates (bottom right corner) of where her car was found on 8/04/2020, with a white arrow pointing to where Brynia's car was parked in the dash cam videos as well.

[REDACTED] had informed me on 5/21/2021 that the case relating to Brynia's death was closed as an "accidental drowning." On 8/4/2021, [REDACTED] further informed me that "evidence points to Brynia having gone voluntarily to the river in own vehicle and consuming alcohol beforehand" and "we whole heatedly believe this is not a homicide."

I disagreed in texting back to him. The autopsy, which is currently listed as undetermined for cause of death, does not support the conclusion of an accidental drowning. There wasn't ample fluid in her lungs for a drowning. I make all assertions, rightfully so, that the woman being carried in the dash cam video dated 8/03/2020 is Brynia's body. She is deceased in the video. The video of a woman's [REDACTED] limp body does not indicate that Brynia went to the Kern River voluntarily. According to the autopsy, [REDACTED]




