

Did he know what to look for on the video with him carrying her body?


I told him everything and then said maybe they could enhance and frame by frame it...

Greetings Karen,



I went to KGET's website, and entered "Chief Greg Terry" in the search terms and looked for any patterns of his public appearances that were not directly related to a current investigation that the BPD were already involved in. I looked for articles that had a PR approach, the PR topic, and the date/timestamps of the media outreach.



Recall the complaint I made (in texting to Det Frank McIntrye) that I was considering going public with the videos if we couldn't get proper help – and that I had also already posted them on YouTube (unlisted.)

BPD released this on article and live interview on Nov 3, 2021 (link below) – the very next day after I pointed out their mishandling of my niece's death investigation by submitting the dash cam videos.

The article mentions Missing Persons (which Brynia was), Homicides (Brynia's death case investigation leans toward this since her body was dumped), and links drugs to homicides - which in general terms can be linked to an "accidental drowning."


