

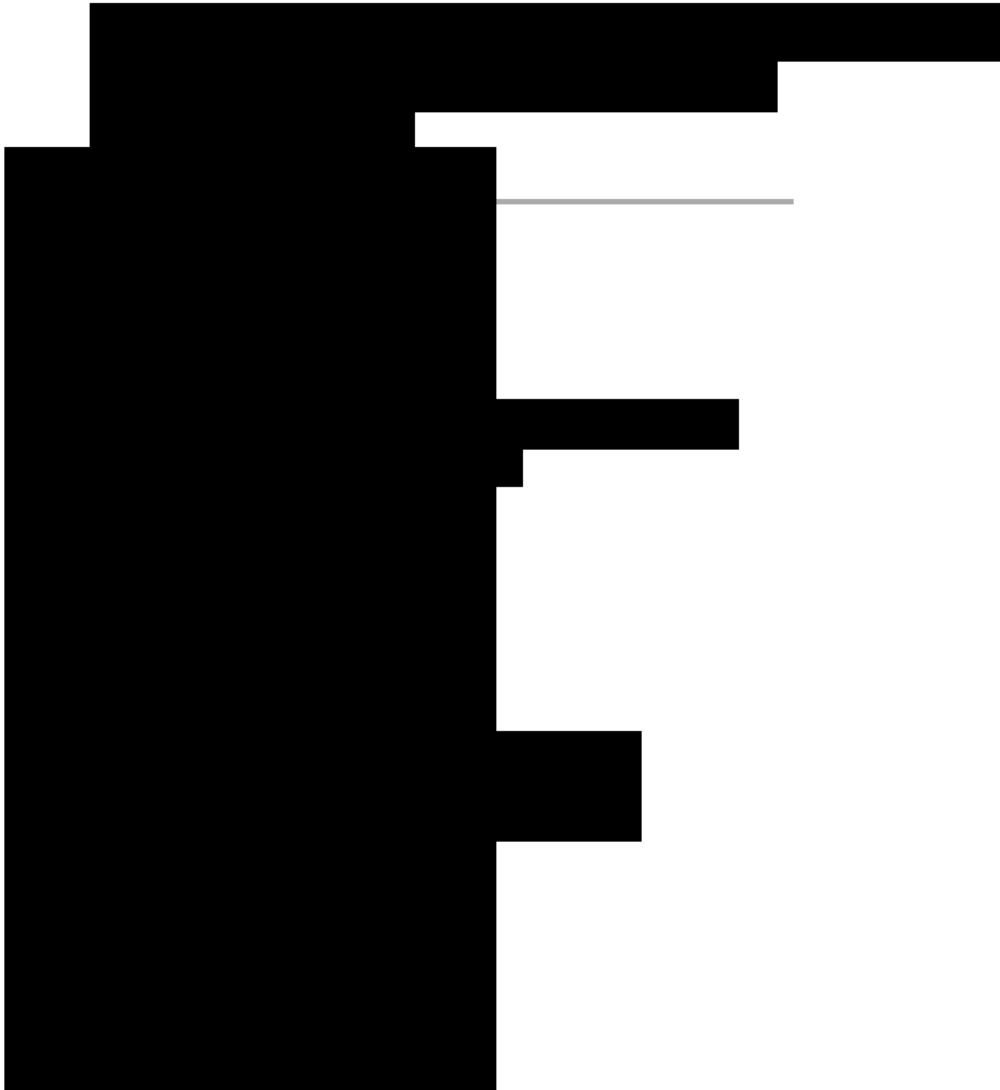

Thank you Karen. Any findings regarding this case will be based upon the evidence collected. A legal threshold of "Probable Cause to Believe a Felony has Occurred" must exist before we consider arresting anyone for a criminal death. If the evidence supports charges against anyone, it will be presented to the District Attorney's Office for review. A higher legal standard of "Proof Beyond a Reasonable Doubt" must exist before the District Attorney could bring charges against a suspect. In reviewing the evidence provided by you, as well as the other evidence collected during this investigation, we will work to evaluate the possibility of bring charges against anyone. If we make an arrest, or otherwise seek charges against anyone, I will be sure to let you know, but will not do so in a manner that compromises this investigation. I thank you for your help.

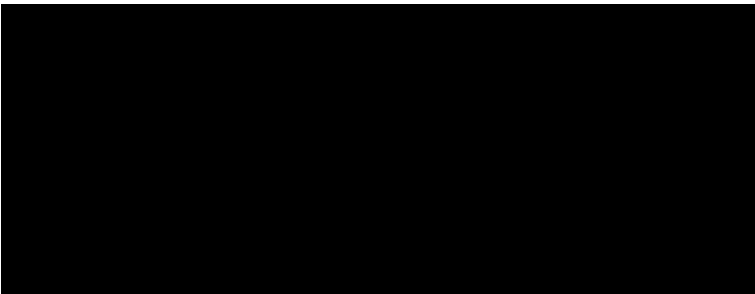

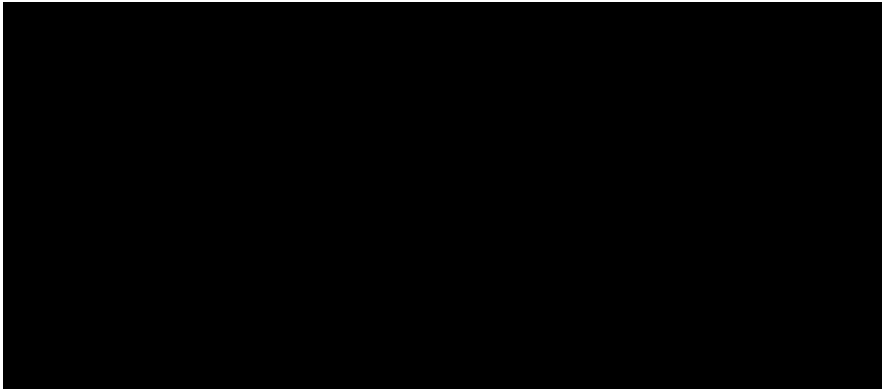

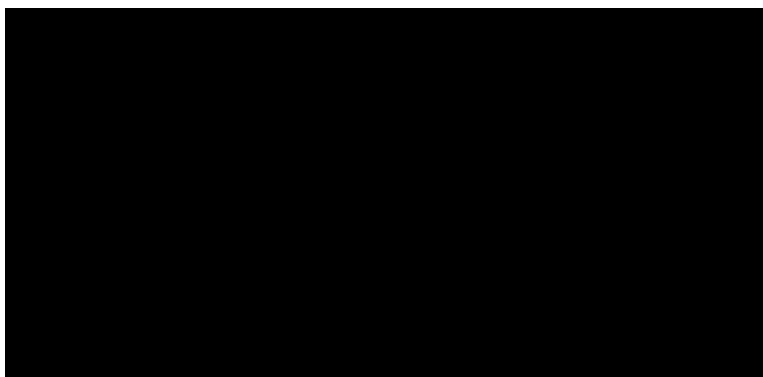
